



AIRCRAFT FLEET




There were 324 aircraft registered in Iceland, at the end of the year 1995, as compared to 313 the preceding year. The increase is 4%. The number of registered aircraft has never been higher in the last ten years.

The number of heavy aeroplanes (> 5,700 kgs) increased by eight, the number of light aeroplanes (< 5,700 kgs) by two and the number of helicopters by one. The number of gliders is unchanged.

Over the past ten years the number of Icelandic aircraft has increased by an average of 2% annually. The average annual change over the past five years is zero.

PERSONNEL LICENCES

Number of licence




There were 1,910 valid personnel licences at year end 1994, an increase of 2% from the preceding year.

The main groups of licences include: private pilots = 571, commercial pilots = 489, aircraft maintenance technicians = 249, air traffic controllers = 93, flight instructors = 92, student pilots = 80, glider pilots = 58, flight engineers = 52 and flight dispatchers = 23. At year end 1995 there were 184 valid IFR licences.

From 1994 to 1995 the number of licences went up in varying proportions in the following categories: student pilots 13%, flight engineers 13%, commercial pilots 8%, flight dispatchers 5%, and aircraft maintenance technicians 4%. On the other hand, the number of licences in the following categories dropped: glider pilots by 20%, private pilots by 5%, and air traffic controllers by 1%. Pilots with IFR licences increased by 6%.

Over the past ten years the number of valid personnel licences has increased by an average of 3% annually. The average annual increase over the past five years is 4%.

REYKJAVÍK OCEANIC AIR TRAFFIC




66,292 aircraft entered the Reykjavík Oceanic Control Area in 1995, a 3% drop from the preceding year. Military air traffic comprises 10% of total air traffic in 1995.


Over the past ten years air traffic in the area has increased by an average of 2% annually. The average annual change over the past five years is 1% increase.


DOMESTIC PASSENGERS






377,343 domestic passengers embarked at Icelandic airports offering scheduled services in 1995, an increase of 4% from the preceding year. Over the past ten years the total number of domestic passengers embarking at airports with scheduled services has increased by an average of 2% annually. The average annual increase over the past five years is 2%.

INTERNATIONAL PASSENGERS




Number of passengers Departure/arrival passengers Transit passengers 1,000,000 900,000



669,836 international passengers used Icelandic airports with scheduled services in 1995, an increase of 10% from the preceding year.

Over the past five years the volume of international passengers at Keflavík International Airport has increased by an average of 7% annually. Keflavík is the main gateway for international air traffic to and from Iceland..






2,499 tonnes of mail and cargo were transported domestically in 1995, a drop of 6% from the preceding year. Cargo transport declined by 5%, mail by 10%.


Over the past ten years total domestic mail and cargo have dropped by an average of 6% annually. The average annual decrease over the past five years is 8%.

INTERNATIONAL MAIL AND CARGO



International cargo and mail increased by 13% in 1995, amounting to a total of 19,578 tonnes. Cargo increased by 14%, mail by 2%. Over the past five years international cargo and mail transported through Keflavík International Airport has increased by an average of 8% annually. Keflavík is the main gateway for international air traffic to and from Iceland.

DOMESTIC AIRCRAFT MOVEMENTS



Domestic aircraft movements (take-offs and landings) decreased in the area of scheduled and charter services by 4%, to a total of 60,332. Touch-and-go landings numbered 63,098, an increase of 22%, and other domestic movements were 33,372 giving a decrease of 20% over the preceding year.

Total aircraft movements at Icelandic airports with scheduled services in 1995 were 178,132, an increase of 2% from the preceding year. 156,802 were domestic movements and 21,330 international movements.

Over the past five years domestic aircraft movements have decreased by an average of 1% annually. The average annual change over the past five years is zero for international aircraft movements.
