# SUSTAINABLE TRAFFIC INCENTIVE

Isavia Ltd. Keflavik International Airport / Valid from November 1st 2023





#### Introduction

The aim of the incentive is to reward airlines contributing to sustainable passenger growth at Keflavik International Airport.

#### **Sustainable Traffic Incentive**

The incentive is for incremental traffic growth above the previous IATA season, subject to the criteria below. Departing and departure transfer passengers are eligible for the incentive. Infants are excluded from this rebate as they are exempt from airport charges. Growth is calculated on the entire network operated by each individual airline rather than at route level.

The Sustainable Traffic Incentive applies at the following amounts per passenger for incremental traffic:

- Long Haul Destinations
  - €6.0 for IATA Summer Season (Apr-Oct)
  - o €8.0 for IATA Winter Season (Nov-Mar)
- Short Haul Destinations
  - €4.0 for IATA Summer Season (Apr-Oct)
  - €6.0 for IATA Winter Season (Nov-Mar)

Short Haul Destinations are all destinations inside geographic Europe with the addition of Greenland. Long Haul Destinations are all destinations outside geographic Europe with the exception of Greenland.

## Criteria

To qualify for the Sustainable Traffic Incentive an airline must meet the following criteria:

- Airlines operating to Short Haul Destinations need to achieve a minimum of 25,000 departing passengers per year before qualifying for the incentive.
  - If an airline operating to Short Haul Destinations exceeds the 25,000 departing passenger threshold in the current year, it will receive the Sustainable Traffic Incentive for all incremental departing passengers compared to same season the year before.
    - For the year 2023 the threshold will be 17,000 departing passengers per year.
- The Sustainable Traffic Incentive applies to scheduled traffic only.
- Routes eligible for the New Route Incentive scheme are excluded from the Sustainable Traffic incentive.



# **Required information**

The airline must provide Keflavik International Airport with the following information:

- Name and address of the airline
- Contact information for the relevant contact person with the airline
- IATA code for the destination airport
- The aircraft type to be used on the route, MTOW and seat capacity
- Estimated load factor
- Weekly number of departures, total number of departures and length of the season

## **Crediting terms**

- Calculations and payments will be made after each IATA season (Winter/Summer).
- The Sustainable Traffic Incentive continues to apply provided an operator is fully compliant with the criteria determined by Isavia.

### Disclaimer

If the airline fails to meet its obligations to Isavia regarding the payment of invoices or other matters the airline will be disqualified from receiving the discounts. Isavia reserves the right to cancel any incentives or to modify eligibility criteria, cost levels or time periods applicable for the Sustainable Traffic Incentive. Any dispute arising from this agreement to be settled in an Icelandic Court by Icelandic law.

Isavia reserves the right not to pay the incentive to companies towards which Isavia has overdue claims.
